**Important Notice Regarding Conduct of Counselling for Admission in programme
B.Sc. (H) Nursing, CET Code 115**

Subject: Conduct of Common Counselling by Medical Counselling Committee (MCC), Directorate General of Health Services, Govt of India for admission in programme B.Sc. (Hons) Nursing programme during the Academic Session 2022-23 in respect of affiliated colleges of GGSIP University.


Consequent upon the decision of the University pursuant to the meetings in the O/o Directorate General of Health Services, Govt of India, it is stated that during the Academic Session 2022-23, the admission counseling for programme B.Sc. (Hons) Nursing CET Code 115 shall NOT be carried out by the University.

It is further informed that the Common Counselling for admission in B.Sc. (Hons) Nursing; for affiliated institutions / colleges conducting B.Sc. (Hons) Nursing programmes, **shall NOW BE CARRIED OUT by Medical Counselling Committee (MCC), Directorate General of Health Services, Govt of India.**

In view of this, it is informed that all the candidates who had registered GGSIPU Portal i.e. www.ipu.admissions.nic.in for centralized online counseling of B.Sc (Hons) Nursing Programme for the Academic Session 2022-23, are now required to Register themselves on Medical Counselling Committee portal i.e www.mcc.nic.in as and when the counseling process will be notified by Medical Counselling Committee, DGHS, Govt of India.

The Registration fees of Rs. 1200 deposited by the candidates while applying on the University portal, shall be refunded to them in due course of time.
